## TOWSON, MD

### FROM THE NORTH (PENNSYLVANIA)

Take 83 South to 695 East towards Towson. Take Exit 29A Cromwell Bridge Rd. Continue straight through the intersection and up the hill at Towson Overlook. The CVRC / PET-ER offices will be straight ahead at the top.

### FROM THE SOUTH (WASHINGTON D.C.)

Follow MD-295 North towards Baltimore. Take the Harbor Tunnel Thwy/895 North exit. Merge onto 95 North. Take exit for 695 North toward Essex / Towson. **\* See bold below.**

### FROM ALL POINTS EAST

Follow 695 West towards Towson. Take Exit 29A Cromwell Bridge Rd. Continue straight through the intersection and up the hill at Towson Overlook. The CVRC / PET-ER offices will be straight ahead at the top.

### FROM ALL POINTS WEST

Follow 695 East towards Towson. **\* Take Exit 29B-A Loch Raven Blvd. At the light turn right onto Cromwell Bridge Rd. At the next light make a left turn up the hill at Towson Overlook. The CVRC / PET-ER offices will be straight ahead at the top.**

## ANNAPOLIS, MD

### FROM THE NORTH (BALTIMORE)

Take 695 West to 97 South to Route 50 East (towards Bay Bridge.) Take exit 23 Parole. Right turn at exit ramp towards Crownsville. Left turn at 2nd light onto Defense Hwy MD-450. **\*Office is 0.75 mile down on left side in the American Truck & Bus Business Center, Suite #101 Animal Dental Center & Animal Eye Care.**

### FROM THE SOUTH (SOLOMON'S ISLAND, SOUTHERN MD)

Route 2 Solomon's Island Rd. North. Left on MD-450 West. Left turn at 2nd light onto Defense Hwy MD-450. **\*See bold above**

### FROM THE EAST (BAY BRIDGE)

Follow Route 50 West to Annapolis Take Exit 23B Crownsville. Left at exit ramp onto MD-450. Left turn at 1st light onto MD-450 Defense Hwy. **\*See bold above**

### FROM WASHINGTON / VIRGINIA D.C. AREA

Follow Route 50 East to exit 23 Parole. Right turn at exit ramp towards Crownsville. Left turn at 2nd light onto Defense Hwy MD-450. **\*See bold above**

## COLUMBIA, MD

### FROM THE NORTH (BALTIMORE)

Take 695 West to 70 West to US-29 South. Take left exit 22 for MD-100 East toward Glen Burnie. **\* Take exit 1C to Centre Park Drive. Office signage is visible from MD-100 and directly under large water tower landmark. Take immediate left into Centre Park 100 Business Center.**

### FROM THE SOUTH (SILVER SPRING, WASHINGTON D.C.)

Our office is accessible via US 29-N as well as from I-95N. From US-29N take exit 22 toward MD-100 East **\*then see bold above.** From I-95N, take exit 43B to MD-100W toward Ellicott City. Use Exit 1B-1C for Executive Park Dr. Left onto Executive Park Dr. and left again onto Columbia Parkway 100. Turn left onto Centre Park Dr.

### FROM THE WEST (GAITHERSBURG)

Follow MD-200E to US-29N. From US-29N take exit 22 toward MD-100 East **\*see bold above.**

### FROM THE EAST (BOWIE / ODENTON)

Follow Route 50 East to exit 23 Parole. Right turn at exit ramp towards Crownsville. Left turn at 2nd light onto Defense Hwy MD-450. **\*See bold above**

## YORK, PA

### FROM THE NORTH (HARRISBURG)

Take I-83 South towards York. Continue on I-83 South to EXIT 16B PA-74 North / Queen St. Make a right turn at the exit ramp onto South Queen St. **\*Our office is 1.3 mi on the left, located within the Animal Emergency & Referral Center of York.**

### FROM ALL POINTS SOUTH

Follow I-83 North towards York. Continue on I-83 North to EXIT 16B PA-74 North / Queen St. Follow ramp towards right onto South Queen St. **\*see bold above**

### FROM THE EAST (LANCASTER)

Follow US-30 West towards York. Merge onto I-83 South and continue south to PA-74 North. Take EXIT 16B for PA-74 North / Queen St. Right turn at exit ramp onto S. Queen St. **\*see bold above**

### FROM THE WEST (GETTYSBURG / HANOVER)

Follow US-30 East towards York. Merge onto West Market St. Turn right at PA-74 South/Queen St. **\*Our office is located 1.7 mi on the right within the Animal Emergency & Referral Center of York.**
